NOTICE

Provisional allotment under CRP- PO/MT-XII has been done based on the category-wise vacancies for 2023-24 for PO/MT cadre as furnished by the Participating Banks (details vide Annexure A) subject to availability. Candidates can view their result status on authorised IBPS website www.ibps.in by entering their Registration Number or Roll Number and Date of Birth or Password.

Please note:

1. No change in the data already registered by the candidate in the online application form is possible.
2. The said provisional allotment has been done based on merit-cum-preference keeping in view the spirit of various guidelines issued by Govt. of India/Others from time to time, administrative exigency etc.
3. **A candidate belonging to reserved category, selected on the basis of norms as applicable to General Category, has been treated at par with a General category candidate for drawing up the merit list. Such a candidate has not been adjusted against a reserved post.**
4. In the event of two or more candidates having obtained the same score, merit order is decided as per date of birth (the candidate senior in age is placed before the candidate junior in age), as per the prevailing practice.
5. The provisional allotment is subject to the candidate fulfilling the criteria for Participating Banks and identity verification to the satisfaction of the allotted bank. This does not constitute an offer of employment. In case it is detected at any stage of the recruitment process that, the candidate does not satisfy the eligibility criteria his/her candidature/ chance in the process shall stand forfeited.
6. Offer of appointment including terms and conditions, formalities for verification, joining etc. will be issued by the allotted Participating Bank in due course. Decision of Participating Banks shall be final and binding.
7. The recruitment process/ appointment is solely the purview of the Participating Banks and shall be final and binding. IBPS has no role in this connection.
8. If the candidate does not avail the offer/ appointment from the allotted Participating Bank his/her candidature/ chance in the process shall stand forfeited.
9. A list of candidates (in Registration Number order) provisionally allotted will be displayed on authorised IBPS website on or before 01.05.2023. However this does not guarantee offer of employment. Decision of Participating Banks shall be final and binding.

10. A **reserve list** to the extent of approximately 10 percent of the vacancies under each category has been kept, subject to the availability of candidates, as per advertisement dated 02.08.2022. **This does not guarantee allotment to/recruitment by the Participating Bank(s)**. In the event of Participating Banks providing further vacancies during April 2023-March 2024, provisional allotment will be carried out for the candidates in the reserve list. However if no vacancy is furnished by the Participating Banks owing to exigencies or otherwise during the validity period the candidates under the reserve list will not be considered for allotment. **The reserve list will expire automatically on 31.03.2024 without any notice.**
11. **Candidates who are not provisionally allotted or are not in the reserve list will not be considered for any further process under CRP-PO/MT-XII for vacancies of 2023-24.**
12. The category wise maximum and minimum scores (combined scores in Online Main Examination and Interview out of 100) for the provisional allotment and reserve list is indicated in Annexure B.
13. The decision of IBPS in provisional allotment of Banks is final and binding upon the selected candidates. However IBPS reserves the right to cancel, reallocate Bank-wise allocation depending upon exigencies or otherwise.
14. No correspondence will be entertained from the candidate about allotment status and process.
15. Provisional allotment is subject to Court order, if any.
